1. I understand that all Rules, Policies, and Procedures are available both on the Club's website and from the Club office and it is my responsibility to read this member information and abide by them.
2. **Regular Memberships** - I understand that all regular memberships are on a basis called a membership year which runs from the first day of the month this application is approved until June 30<sup>th</sup> of the next year and my membership shall continue from year to year (July 1 to June 30) except upon termination by action and notice of the Board of Directors or resignation as provided by the By-Laws, Rules, and Regulations of the club. I have been duly informed that resignations are effective only at the end of my membership year (June 30<sup>th</sup>).
3. \* **Special Memberships** - I understand this Special Membership begins the day this application is signed with the introductory dues rate in effect at the time plus a Capital Fund Fee of \$20 per month with no fee for a locker or a monthly food and beverage minimum my first year. I also agree my account will be charged \$35 per year to maintain a valid USGA Handicap. During this membership period, Special Memberships are exempt from any assessments levied by the Board of Directors. After this membership period, I have the option to continue my membership into a second year with the dues rate changing to the 2<sup>nd</sup> tier level accepting all applicable mandatory charges for locker, handicap, capital fund, and the monthly food and beverage minimum as required. My second year membership will continue on through June 30<sup>th</sup> of the following year.
4. My signature below evidences that I understand I am subject to all terms and conditions of the By-Laws, Rules, and Regulations of the Club as well as any resolutions passed by the Board of Directors.
