1. **Regular Memberships:** I understand that all Memberships are annual memberships and the monthly fee as selected by me on the previous page is the monthly installment of the total membership fee for the year. The membership year runs from the first day of the month that this application is approved until June 30 of the following year. (Exception: If the application is signed between March 1 and June 30, the membership must continue to June of the following year.) The membership will then continue from year-to-year **commencing July 1 through June 30 of the following year**. The membership can ONLY be terminated prior to June 30 by written request to the Board of Directors under the provisions required by the By-Laws and the Rules and Regulations of Willowbrook Country Club. This application requires a credit card and a copy of the applicant's driver's license on file in the office. If the Full Membership is chosen, the Initiation Fee is non-refundable.
2. **One-Year Exemption:** During my first membership year, my membership is exempt from any assessments levied by the Board of Directors.
3. **Special Memberships:** I understand this Special Membership begins after approval by the Board of Directors and as stated on the application. Mandatory fees (i.e., Capital Fund Fee, Monthly Food & Beverage Minimum, yearly Handicap Fee or any other required fees under the Special Memberships) are exempt from any assessments levied by the Board of Directors. After the special membership year ends, I have the option to continue into an available Regular Membership offered by the Club and accept all applicable mandatory fees that accompany that membership (i.e., Capital Fund, Locker, Handicap and Monthly Food & Beverage Minimum). **IF I DO NOT INTEND TO EXTEND MY MEMBERSHIP, I AGREE TO NOTIFY THE BUSINESS OFFICE IN WRITING AT LEAST 30 DAYS BEFORE THE END OF MY CONTRACT YEAR, AS STATED IN THE SPECIAL MEMBERSHIP.
